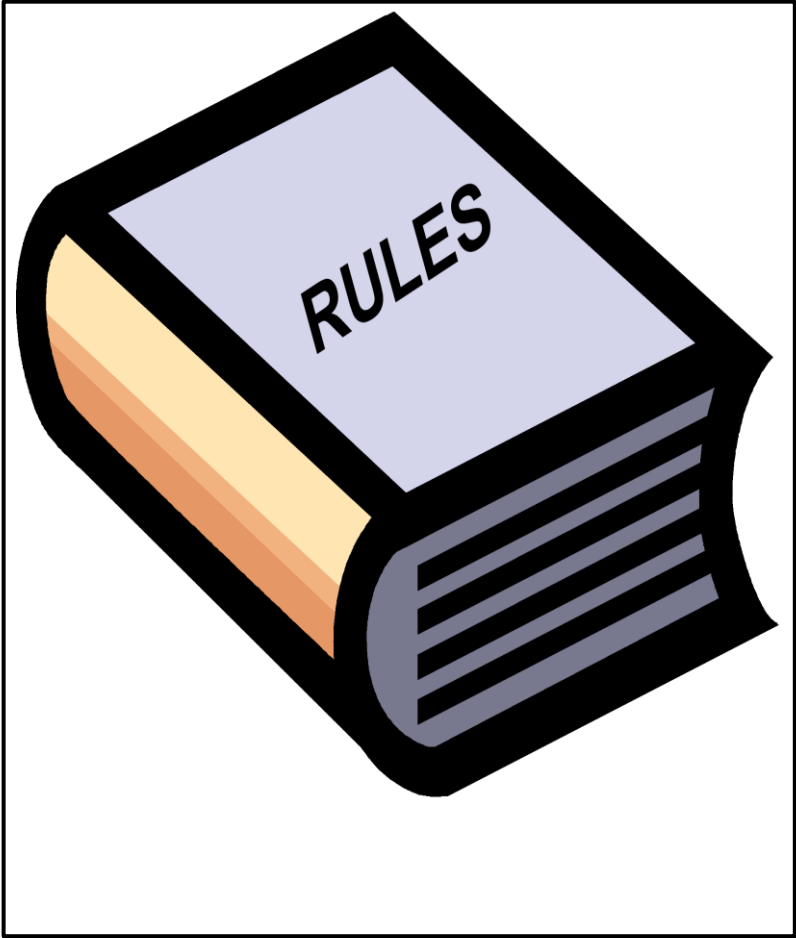

## **RULES FOR WEEKLY PLAY**

1. **MEMBERSHIP:** To be a member of Land Harbor Ladies 18 Hole Golf Association (LGA) and to compete in play, you must be a current member of the Land Harbor Golf Association, as defined in the LGA Constitution and By-Laws, Article V (Avid, Associate, Casual and Monthly Members).
2. Members must also pay the annual membership fee for the Land Harbor Ladies Golf Association. Birdie Tree participants pay \$5.00 per year (which can be included in the check to the Treasurer with annual membership fee).
3. **HANDICAP:** To compete in weekly play, a Handicap from the previous year carries over. New members must post 54 holes (which are attested by another Land Harbor member) on GHIN to establish a Land Harbor handicap and must be a paid member of the Ladies 18 Hole Golf Association. (New members can supply a current Handicap verified by their club pro; or members without an established handicap may work with our LGA Handicap representative to determine how best to set up a “temporary” Land Harbor Handicap.
4. **DEFAULT TEE ASSIGNMENT:** At the start of each season, returning members will be assigned to their previous year’s default tee. A player may opt to change their default tee assignment one time during the season with notification to the league manager **PRIOR TO JUNE 1**. After that date, only **NEW** members will be given three weeks to choose their default tee for future competitions. **EXCEPTION** -- annually during the two weeks of the ClubChampionship, any member may opt to play from the **RED** tees to compete for the title “Club Champion” regardless of their regular default tee assignment.

5. **PLAYDAY:** Ladies play day is Tuesday. Play usually begins early, at a time directed by the Golf Operations manager in concert with the LGA Tournament Committee.
6. **WEEKLY SIGN UP:** The Deadline for signing up to play and paying the required fee is 12 noon on the preceding Sunday. You will need to have a credit card on file or cash in your account to cover the weekly playday fee. For signup, you will receive an email from Golf Genius prior to each playday. Refunds will NOT be given for cancellations after teams and pairings have been made.
7. **SCHEDULING PLAY:** Tee times and pairings will be communicated through Golf Genius and posted by the Tournament Committee on the LGA Board by Monday afternoon.
8. **RAIN POLICY:** The Tournament Committee Chairperson(s) has the authority to discontinue play for inclement weather. If play has not begun, and the weather is uncertain, **please check your email.** The Tournament Chairperson will send an email at least one half (1/2) hour before scheduled play if it is determined that the weather will not allow for organized play. If you do not have email access, please call the Golf Shop.

**During play:** You will be notified on the golf course if play is delayed or discontinued. If the field finishes 9 holes, it will become a 9-hole event. If a complete flight finishes 18 holes, it will be counted as such. All Birdies will be counted regardless of the number of holes completed. *If play is cancelled, entry fees will not be charged to your account.*

9. **GUESTS:** On a space available basis, and upon special request to the Tournament Chairperson, a member may invite up to four (4) guests per season to play on Ladies play day. Guests are not eligible to play in Team Events, the Championships, or Match Play, and are not eligible for payouts on any other play day.

10. PACE OF PLAY: Slow play is a source of frustration during a round of golf and impacts the Golf Course Management in maintaining scheduling commitments throughout the day. Let's help each other maintain the pace of play by assisting the Captain in her responsibility to keep up the pace of play by:
  - a. Always being ready to play when it is your turn.
  - b. Helping your group keep up with the group in front.
  - c. If possible with regard to your health and safety, take your club(s) and walk to your next shot, rather than waiting for the cart to take you.
  - d. When leaving the green, please do not take time to clean your clubs until the next tee box. You may be able to get into the cart with your club in hand and place it in your golf bag at the next tee box.
  - e. Giving the Captain your score at the next tee box for the hole just completed.
  
11. SCORING: The first name on the scorecard is the Captain of the group. The Captain must maintain a neat, easy to read scorecard and verify each player's score. The Captain is responsible for turning in the group's completed score cards: totaled, signed, dated and attested.
  - a. It is the responsibility of each player to check her score for accuracy and to see that the card is signed and attested. A player can be disqualified for an incorrect score. If a player questions tabulation, the player has until 4:45 pm on Thursday of the same week to contact the Tournament Committee Chairperson(s).

- b. If during play, there is a difference of opinion regarding how a hole should be scored, a player should play two balls and bring the question to the LGA Rules Chairperson.
12. **POSTING SCORES:** Weekly play day scores will be given to the Handicap Representative, who will ensure all scores are posted. (See item 12 for scores on other than play days.)
13. **ANNUAL AWARDS:** They will be given out at the Year End Awards Luncheon. To be eligible, a member must be in good standing and shall have played a minimum of four (4) 18-Hole LGA Play Days in the current year prior to the start of 18-Hole LGA Championship play. The Red Tee Players and the Gold Tee Players will compete for Ladies' Championships. The overall Ladies Champion will be a player from the Red Tees. Most Improved will also be awarded to ladies playing from Red Tees and Gold Tees. Birdies will also be awarded at the Awards Luncheon.
14. **POSTING OTHER SCORES:** Keep scores in all forms of play (not just Ladies Day) except Scrambles, and post them on GHIN as follows:
- a. Post scores when you play at least 13 holes.
  - b. On the holes that you did not play, record a par plus any handicap strokes you would have received.
  - c. **MOST LIKELY SCORE:** If you pick up on a hole because you cannot help in a team situation, record the number of strokes (including penalty strokes) taken thus far, plus the number of strokes it will take to complete the hole from that point, not to exceed your maximum per hole score limit, Net Double Bogey, defined below. An "X" should precede the score on the scorecard.

**Net Double Bogey** (Par + 2 + any handicap strokes you receive) is now the maximum per hole score, which replaces the former **Equitable Stroke Control (ESC)** calculation. For example, if based upon your handicap you are marked to receive 2 strokes on a par 4 hole, you may only take a maximum of 8 (par + 2 for double bogey+ 2 handicap strokes).

Remember: **SLOW PLAY** is the #1 source of frustration during a round of golf. Help each other maintain the pace of play!

Let's all **CHIP IN** to fill divots on the golf course. If you're ready and waiting to hit, please fill in the divots nearby, and your own made after hitting.

## THE MOST RECENT RULES CHANGES

- A ball is considered holed when any part of the ball is deemed below the green surface in the cup.
- If ball is accidentally moved on green by mark or otherwise it must be replaced before playing it. If not, 2 stroke penalty.
- When taking a drop “back on the line”, balls can roll up to one club length in any direction, even forward, to be in play.
- Search time reduced from 5 minutes to 3 minutes.
- Ball moved during search – replace, no penalty.
- Embedded ball – free relief anywhere through the course.
- Measuring a drop – use longest club (except putter).
- Dropping – drop from knee height rather than shoulder.
- Taking stance on wrong green is not permitted.
- Ball unintentionally hits player or equipment, no penalty.
- Double hit – no penalty, now counts only as the 1 stroke.
- Touching sand in bunker incidentally is permitted.
- Loose impediments can be removed anywhere including hazards.
- Dropping a ball out of bunker – 2 penalty strokes.
- Water hazards now called “penalty areas”.
- Touching ground in penalty area – no penalty.
- All damage to green can now be repaired.
- Positioning a club for alignment is not permitted.
- Caddie assisting with alignment is now not permitted.
- Putting wit flag stick in hole is now permitted.
- Ball wedged against flagstick and side of hole is now deemed holed.

**ARTICLE I - Name and Status**

The name of this association shall be “The Land Harbor 18 Hole Ladies Golf Association”. It shall be a non-profit organization.

**ARTICLE II - Purpose**

The purpose of the organization shall be to promote and foster:

Interest in golf among female players, good fellowship, good sportsmanship, friendly competition, and appreciation for the rules of play through weekly play and tournaments as may be decided by the Executive Committee.

**ARTICLE III – Leadership - Executive Committee and the Board**

The **Executive Committee** shall consist of the President, Vice President/President Elect, Secretary and Treasurer.

The **Board** shall consist of the Executive Committee, the Committee Chairs and Co-chairs, and the immediate past President. (The past President shall be in an advisory role, and shall be a non- voting member of the Board.)

**ARTICLE IV – Duties and Responsibilities of Leadership**

The following are the general duties and responsibilities of each Executive Officer and the Board. Detailed job duties are recorded in the Executive Committee Jobs Binder located in the Ladies Locker room.

President:

1. Shall have primary responsibility for all LGA business.
2. Shall preside over all meetings of the Executive Committee, the Board, and the General Membership.

3. Shall appoint LGA members to serve as Chairs of LGA events and tournament committees as she and/or the Board deem(s) necessary.
4. Shall promote two-way communication with the Executive Committee, the Board, and the General Membership, e.g., by emailing LGA minutes, agendas, and updating members about key events and other important information, etc.

Vice President:

1. Shall perform the duties of the President when the President is absent.
2. Shall serve as assistant and consultant to the President.
3. Shall serve as 18-Hole LGA Representative on the Golf Committee.
4. Shall advise and support the Committee Chairs.
5. Shall ensure activities are coordinated with the Golf House Staff.
6. Shall award the LGA Championship(s) at the end of year luncheon Awards meeting.
7. Shall review the Nominating Committee's proposed slate prior to its presentation to membership for voting purposes.
8. Shall become the next President once the current President's tenure is completed (or vacated for any reason).

Secretary

1. Shall keep a detailed record of minutes of all meetings of the General Membership, the Board and Executive Committee, including identifying items that require follow-up and provide to the President for approval and distribute.
2. Shall, once approved by the President, post copies of the General Membership minutes.
3. Shall assist the Executive Committee with Robert's Rules of Order requirements.
4. Shall maintain and update the job duties binder (which will contain the job duties of the Executives and the Committee Chairs).
5. Shall ensure all members receive information requiring membership vote (either email or regular mail) and shall tally and report the results of such a vote.



## Treasurer

1. Shall prepare a Proposed Budget by December 1 for approval of the new Executive Committee. Once approved, the budget will be forwarded to the Board no later than January 1 for input and agreement.
2. Shall collect all dues from members and deposit in a timely manner.
3. Shall maintain an updated list of all members.
4. Shall keep and maintain an accurate up-to-date account of all funds received and paid.
5. Shall pay all bills in a timely manner and make available funds to various Chairs for special events, luncheons, tournaments, and awards, and to Golf House. Checks may be signed by either the President or Treasurer.
6. Shall prepare a monthly updated accounting of the Association's overall financial standing at the end of each month and advise if any proposed vs. actual budget figures are not in alignment.
7. Shall prepare a Year End Financial Statement completed by October 1.

## Leadership Duties of the Board:

The affairs of the Association shall be managed by the Board in meetings scheduled by the President at least three times from May to September and via email. A majority of its members present in a meeting shall constitute a quorum and must be present to vote. If the Board is requested to vote via email, usually during the off-season, a majority vote of the Board membership will be required.

1. Shall consist of the Executive Committee, the Committee Chairs/Co-Chairs, and the most recent past President (non-voting).
2. Shall adopt the annual budget.
3. Shall provide a list of all Chairs/Co-Chairs to the LGA Website and may add or delete positions from time to time. Responsibilities associated with the committees shall be provided to the Chairs by the Board.

4. Shall present proposed amendments and/or changes to the Constitution and By-laws for a vote of the general membership.

## ARTICLE V - Membership Fees & Eligibility

Annual dues shall be charged for all members payable to the LLHLGA and given to the Treasurer. Dues amounts will be announced at the last scheduled meeting each season applicable to the next season. Most weekly play will also require a fee to participate.

To be eligible for membership in the LGA, ladies must be in good standing in one of the following Land Harbor Golf Membership categories: *Avid, Associate, Casual or Monthly (defined in the Linville Land Harbor Property Owners Association Rules and Regulations as eligible for organized play).*

Only Avid, Associate and Casual members may compete in the 18-Hole LGA Championship, as indicated in the Linville Land Harbor Golf Club Golf Handbook.

- LGA Member responsibilities:

All types of memberships must have an appropriate 18 Hole Handicap, established with five scores played at Land Harbor attested by another Land Harbor member, unless a new member supplies a current Handicap Index verified by the LGA HCP representative. (A Handicap from the previous year carries over. New members can supply a current Handicap verified by their club pro, or new members without an established handicap may work with our LGA Handicap representative to determine how best to set up a “temporary” Land Harbor Handicap.)

*EXCEPT FOR ORGANIZED PLAY EVENTS*, all members are responsible for posting their own scores to the GHIN system. This includes LLH scores AND scores from play at other courses.

All members should be familiar with the LGA Handbook’s section -- *Rules for Weekly Play*, the local Land Harbor Golf Club Information Handbook, and rules and etiquette according to the USGA.

**ARTICLE VI - Association meetings and election of officers**

General meetings of the Association shall be held on a Tuesday/play day from May through September, either monthly or at least every other month, as scheduled in advance by the President (usually no less than three (3) meetings each season). The final meeting in September will feature Annual Year-End Awards.

Nominating/electing new officers:

1. A Nominating Committee, consisting of three (3) members shall be appointed by the President no later than July. The proposed slate will be posted and emailed to the members at least two weeks prior to the election.
2. Election of officers shall be at the regular August meeting, with a majority vote of those present confirming the election. If another member in good standing wishes to be considered from the floor, nominations may be taken under Robert's Rules of Order.
3. Elected Officers shall serve for one (1) year, with no person serving more than two consecutive years in the same position. Newly elected officers shall take office on October 1.
4. If any elected officer is unable to fulfill her term, the Executive Committee shall appoint another member in her place to finish the term.
5. The previous position holder will meet with the newly elected officer and exchange all necessary information and documentation.

**ARTICLE VII - Constitution and By-Laws**

The Constitution and By-Laws may be altered by the following means:

Members must be notified of proposed changes either via email or in a regular meeting (or both) at least 20 days prior to the required vote.

A vote may be taken at any regular meeting and the proposed changes passed by a majority vote, provided a quorum of one third of the Association membership is present (Proxy votes are counted as members present when assigned by members who cannot be present).

If a regular meeting is not scheduled (such as during the off season), a vote may be taken via email or regular mail. Proposed changes must be emailed or mailed to the full membership at least twenty (20) days ahead of the requested vote date. One third of the members' votes received will be considered a quorum and the majority will prevail.

Proxy forms will be available during the season in a folder in the Golf Shop for use when a member can't be present to vote at a General Membership meeting. Proxy forms must include the name of the member assigning the proxy, the name of the appointed representative, and be signed and given to/sent to the Secretary prior to the deadline for voting, either in person or by email.

Robert's Rules of Order will prevail.

#### **ARTICLE VIII - Rules and Regulations** – Rules for Weekly Play and Year End Awards

The Association shall have a set of rules and regulations which will govern play. This set of rules is documented in the LGA Handbook – *Rules for Weekly Play*. These rules may be changed by the Executive Committee or at a regular meeting by a majority vote; updated Handbook pages will be provided.
